If selected NHEC will provide a scholarship that covers all major costs of the Institute, as itemized in the Fact Sheet. There is also a post-Institute follow-up process with students which applicants must agree to. The Institute is open to all, and applicants from every race, gender, ethnicity, etc. are welcome to apply. See the “Fact Sheet” and “Application Information: How to Apply” for specifics on the Institute and application process. NHEC reserves the right to make changes as necessary to the NM Institute, including revisions to the curriculum. If selected, students will be notified and given further information. NHEC can provide Institute scholarships to eligible/qualified students only up to the limits of available funding.
